The award recipient will be recognized and their video shown during the NOPHNRCSE training conference, **August 20-24, 2019, in Spokane, WA.** NOPHNRCSE will cover the award recipient's travel, lodging, and meal expenses.

JUDGING CRITERIA MAXIMUM POINTS

#### Conservation on the Farm/Ranch

40 points

- a) Does the landowner have a plan for the entire farm/ranch? If not, what percentage is planned?
- b) Are planned and / or conservation practices consistent with a complete resource management system?
- c) Are operation management and maintenance carried out on a regular basis?
- d) Is soil heath being addressed (i.e. cover crops, reduced tillage, mulching, etc)?

### Impact on the Community

20 points

- a) Do planned and / or applied practices prevent soil and / or chemical runoff from leaving the farm?
- b) Are streams and other water courses adequately buffered?
- c) Is adequate consideration given to air quality?
- d) Does the operation provide produce / products for local use?

## **Conservation Involving Agriculture Leadership**

20 points

- a) Does the landowner participate in field days, demonstrations and other educational events.
- b) Does the landowner serve on boards, committees, and other leadership position.
- c) Does the landowner stay current with technology.
- d) Does the landowner transfer ideas to other farmers?

#### **Economic Viability**

20 points

- a) Is the operation specialized or diversified?
- b) Are any unique or special marketing techniques used?
- c) Does the operation contribute to quality of life of its members?
